There are new problems in college sports competition which are different from the past. Specific performance[5]: market economy has a great impact on physical education teachers. Many middle-aged teachers also emerge in people's minds, going to the seaside, waiting for the opportunity to change, confused thoughts. The instability of the faculty will not only affect the quality of education and the progress of university reform, but also have a serious domino effect on the stability of the whole leadership.
