Research on the Development of Liaoning Province from the Perspective of Northeast Asia Regional Cooperation

Abstract: Northeast Asia is one of the regions with the greatest economic development potential in the world. 2) Weaknesses of Liaoning's participation in Northeast Asia regional cooperation

5. Countermeasures and suggestions for the development of Liaoning in the perspective of Northeast Asian regional cooperation

5.4. Innovation-driven and talent cultivation
