Therefore, it is also the need to solve the current problems of student management to apply the humanistic concept to the management of college students.

## 3. Innovation Path of College Student Management under the Concept of Humanism

Management is an art. Student management in Colleges and universities is a student-centered management art. The innovation of College Students' management under the people-oriented concept should go out of the thinking of traditional administrative management and establish management concepts, systems, mechanisms and methods suitable for the development needs of current college students.

### 3.1. Innovation of College Student Management Concept

The idea of humanism is the core of the innovation of College Students' management idea, that is to respect students' subjectivity, initiative and creativity. Specifically, the embodiment of humanism in the management of college students includes the following aspects. Firstly, establishing the concept of serving students. In recent years, the educational consumption contract relationship has become a new perspective to study the legal relationship between students and universities. As a provider of higher education, colleges and universities should provide high-quality educational services for students. The establishment of this legal relationship breaks the administrative tendency of student management, and reflects the repositioning of the relationship between rights and obligations between colleges and students under the condition of market economy. Therefore, colleges and universities should focus on serving the needs of students. Secondly, giving students the right and opportunity to participate democratically. College students have a certain ability of independent judgment. Most of them grow up in a democratic, free and personality publicity social environment, so it is difficult to accept the administrative order management. College student management should be committed to creating an equal and democratic cultural atmosphere, giving college students more opportunities to participate in decision-making and implementation. Thirdly, establishing the concept of rule of law and promote the rule of law in the management of college students. The principle of rule of law requires that the management of college students should respect the rights of college students, and the negative evaluation of students should follow the principle of procedural legitimacy to protect the students' right to know, cross examination and defense. Just as some scholars said, "integrating and improving the current legal mechanism for expressing the interests of the masses, realizing institutional fairness in the interest game and its agreement with the above interests of the masses is

an important goal and basic direction for improving and innovating management, maintaining social harmony and stability, and ensuring coordinated economic and social development", which is also applicable to the field of university governance and student management.

## 3.2. Innovation of College Student Management System

At present, most colleges and universities in China mainly have two systems, namely, the ideological and political education system with the Party committee and the Youth League Committee as the center and the administrative management system with the student office as the center, and implement the two-level management system of schools and departments or the three-level management system of schools, colleges and departments. This two-tier (or three-tier) and vertical network management system adopts the operation mode of the integration of the party and the government in practice, that is, the Student Work Department of the Party committee and the student office "have two brands and one team", thus forming a management system of combination of sections and blocks and vertical and horizontal combination. The disadvantages of this system lie in the fact that many heads are in charge together, the government comes from many departments, the organization is overstaffed, the management level is many, the management efficiency is low, and the managers are tired of dealing with cumbersome affairs. The administrative management of students is strengthened because of the numerous administrative institutions, which is not conducive to the implementation of the humanistic concept in the management of college students. Based on this, the management system of college students in China should be re integrated and a centralized, coordinated and efficient management system should be established. First, regard student management as an administrative affair, which is under the unified management of the student management department, and establish a unitary management system under the direct leadership of the vice president in charge of student work, with the student office responsible for overall coordination and the secondary units of colleges and departments responsible for implementation. Second, the student affairs office has set up several departments, each with its own responsibilities, which are responsible for the administrative management, ideological and political education, service and other work of college students. Third, establish a professional student management team based on the secondary management units of colleges and departments, and appropriately delegate power to them, so that they can play a fundamental role in student management services. Fourth, colleges and departments have established a system of tutors contacting students. Professional teachers are responsible for contacting several students, answering questions they encounter in their daily life and learning, and guiding them to orderly reflect the situation to the student management departments at all levels of the school, forming a pattern in which tutors and professional student management teams jointly serve students.

### 3.3. Innovation of College Student Management Mode

The management mode of College Students under the humanistic concept is the management with students' self-management as the core, which can be implemented from the following aspects. First, the formulation of student management norms in Colleges and universities should solicit students' opinions extensively and fully. For matters that students are capable of self-management, students can formulate their own code of conduct and report it to the student management department for the record. The resulting student management norms can not only fully reflect the wishes of students, but also follow the principles of democracy, which can improve the implementation of institutional norms. Second, establish diversified student associations, which are responsible for the daily management of students and the construction of campus culture (see Figure 1). At present, the role of various cultural student associations has been well played, which has greatly enriched the cultural life on campus. However, the function of managing service student associations needs to be further enhanced. In particular, some associations tend to be bureaucratic, deviate from their purposes, and seriously damage their credibility. Therefore, we should devote ourselves to the self construction of service student associations in Colleges and universities, and make them become self-education, self-management and self-service organizations for students. Third, with the popularization of the Internet, college students have become an important consumer group of network resources. Micro blog and blog can be used to positively guide and educate college students' education. At the same time, the network is also a "double-edged sword". We should collect, analyze and monitor the network information in a timely manner. In particular, we should take effective measures to avoid the expansion of the impact on College Students' various bad trends on the network. Fourth, taking advantage of the characteristics of College Students' group life, focusing on classes and dormitories, and connecting with student cadres and dormitories, we will carry out self-management services for students in a small range to help students solve problems in real life, especially ideological education and mental health work.
