

Construction and Practice of the Moral Education Model of Integration of Knowledge and Practice in the Party Branch of Medical Graduate Students under Micro-environment

The main academic papers include Zhang Juan's "Research on the Phenomenon of Morality of Contemporary Chinese College Students" [1], Wei Hongwei's "Educational Response to the Separation of Knowledge and Practice" of College Students' Morality and Zhang Yonghong's "The Moral Education Environment of Colleges and Universities in the New Media Age" Challenges and countermeasures and so on [2-3]. In foreign countries, the research on Zhixing mainly focuses on the field of psychology, such as the famous psychologists Lawrence Basulau and Richard Nisbet.

Throughout this period of research, there are mainly the following characteristics. From the research point of view, the focus of current research ignores the close integration of microenvironment and postgraduate moral education, especially for medical graduate students.

From the research content, the current research pays more attention to the theoretical level of micro-environment postgraduate ideological and political education. However, neglecting the postgraduate's moral education practice is still insufficient, and there is a disconnect between knowledge and behavior in moral education; As far as research methods are concerned, the current research pays more attention to the theoretical nature of the research, and lacks systematic empirical research. Therefore, under the background of "micro" era, in which micro-blog, micro-message, micro-film and micro-fiction are the main carriers of communication, this paper carries out the construction and practical research of the moral education model of the unity of knowledge and practice in the Party branch of medical postgraduates, which has certain theoretical significance and practical value.

2. The Current Situation of the Training of the Integration of Knowledge and Practice in the Party Branch of Graduate Students

With the advent of the "micro" era with Weibo, WeChat, micro-movie, and micro-speaking as the main carrier of communication, the moral education of graduate students faces opportunities and challenges. The phenomenon of "information" and "action" is more serious, mainly Expressed in the following aspects:

One is to act without knowing. To act without knowing is to act blindly. At present, some graduate students' Party branches in medical colleges still do not seriously read and understand the relevant policies and documents of the Party and the state, laws and regulations, conscientiously understand the importance and significance of Party building and branch building work, and blindly carry out Party building branch building and other related work without knowing it. For example, the system construction of the Party branch still stays in the macro perspective, without putting forward practical and feasible system and measures in line with the education and training of medical student Party members, which greatly weakens the core role of the Party branch of graduate students. At the same time, influenced by some negative thoughts and public opinion, the values, world outlook and outlook on life of some medical college graduate students have undergone major changes and even distortions. The bad thoughts and behaviors such as admiration for vanity, ignorance, quick success, and academic misconduct have become increasingly prominent. The quality of postgraduate moral education has been increasingly criticized by everyone.

The second is to know. Knowing nothing, it is useless knowledge. Due to the serious clinical and scientific research tasks of medical college graduates, most graduate students are not willing to implement the construction of the party branch, the "three sessions and one lesson" and the organization of democratic life, only in the form, fake big air, and go through the scene; The positivity of subjective initiative is not enough, and the ideological consciousness and political orientation are not high. Without taking the learning and education of firm ideals and beliefs as the primary task of carrying out the political life of the Party branch, the effectiveness of Ideological and political work is not obvious, resulting in many graduate students' lack of firmness in the "four self-confidence". The Party member theme day activities also did not closely focus on the characteristics of graduate students in medical colleges, greatly reducing the role of organizational life in guiding and guiding graduate Party members.

3. Construction and Practice of the Moral Education Model of Integration of Knowledge and Practice in the Party Branch of Medical Graduate Students under Micro-environment

3.1. Focus on "knowledge" and Take the Excellent Achievements of Civilization as the Spiritual Guide to Build a Learning-oriented Party Branch for Postgraduates

The seminar; the organization of postgraduate freshmen to visit the Red Health History Museum of the school; the organization of postgraduate students to participate in community free clinics, postgraduate Party members' representatives to Ruijin to participate in a series of activities such as "inheriting red genes, bearing in mind the mission of the first heart" party spirit education special training class, and so on, to effectively build a service-oriented postgraduate Party branch.

3.3. Promoting "integration" and Building Scientific Research Postgraduate Party Branch on the Platform of Tutors and Research Teams
