economic growth.

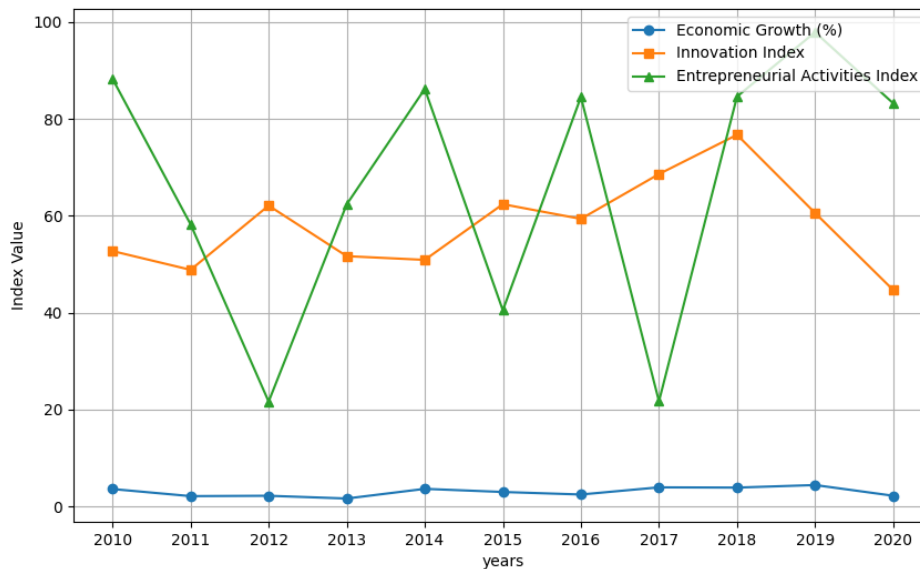


Figure 1 Trends in Innovative Entrepreneurship Education and Regional Economic Growth

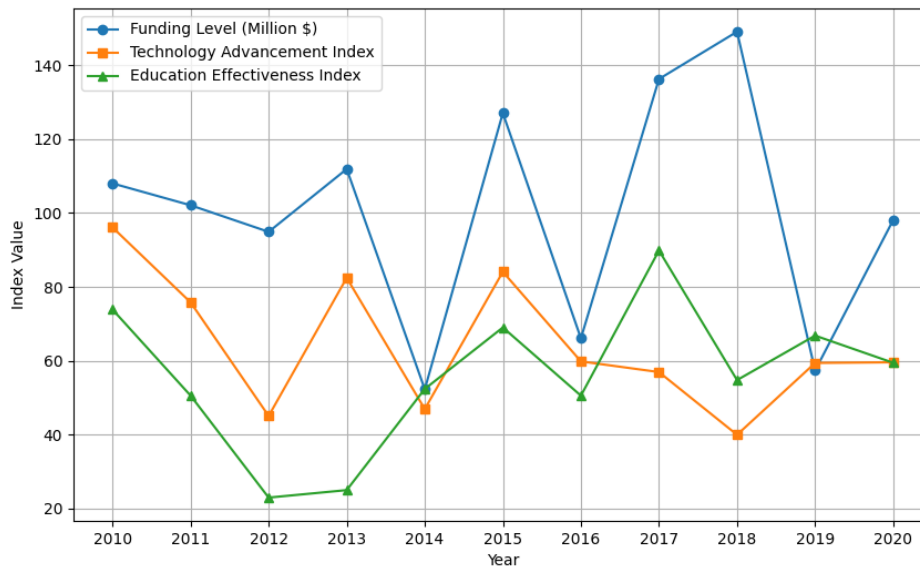


Figure 2 Relationship Between Regional Economic Resources and Effectiveness of Innovative Entrepreneurship Education

reflected in the updating of technology and knowledge but also includes adjustments to educational strategies and objectives to ensure alignment with economic growth (figure 2).
